## 9. Borough and State Reports – Jim Sykes

- a. Race track on lakes and Ice
  - 1. Race track issue does not have much to do with Sutton
- b. Tower ordnance and heights
  - 1. Tower Ordinance will be coming before the MSB. Proposal for towers will require notice to the community council, and landowners, it will be open to public comment. The old tower ordinance has been reinstated at this time. This will take 60 to 90 days to complete the tower permit process.
- c. Ordinance regarding trapping on private land
  - 1. Reports of dogs being injured stepping in traps on valley trails. This ordinance will come before the MSB Assembly.
- d. FEMA is re-doing the flood plan map
  - 1. Remapping of the flood plan in the Sutton area will be conducted.
- e. Funding to remodel the old library
  - 1. Representative Feige recommended that the Sutton Community Council request the funding to remodel the old library to house the Sutton ambulance. This would be a capital project and need to be added to the Sutton Capital Project List.
- f. Multifamily housing requires a permit
  - 1. This ordinance would limit the number of housing units on each piece of property

# g. HB77 has been an issue involving the following

- 1. Public and private partnerships. Fish and Game does not have the resources to address all of these issues. Chickaloon Village has applied for the listing and the state has not acted
- 2. Jim Sykes did not have the four votes needed to move his ordinance forward but may by February 14. Now is the time to send your public comments to the groups meeting on the fisheries. This conference will last for two weeks in Anchorage
